



**2026 First Tee National Championship – Participant Application**  
June 21-25, 2026 | University of North Carolina, Finley Golf Club

**Application Deadline:** March 18, 2026

**Overview:**

First Tee National Championship brings together First Tee’s top players for an opportunity to showcase how the program has helped build the strength of character needed to play under pressure at the collegiate and/or next level. The First Tee National Championship is played at acclaimed college campuses, including University of North Carolina, Clemson University, Notre Dame, and Stanford University, and is the only national event that is purely tournament golf.

The 2026 First Tee National Championship is heading to the Finley Golf Club at the University of North Carolina at Chapel Hill for a 54-hole stroke-play event featuring a Girls and Boys division for up to 48 high school participants ages 14-18. Participants will have the opportunity to experience UNC’s campus and hear from guest speakers throughout the week who will stimulate conversation around First Tee’s values and life skills experiences. The winners of each division will be awarded with the Tattersall Cup named after First Tee Trustee, Fred Tattersall. Each winner will also earn an exemption into the PGA TOUR Champions’ PURE Insurance Championship Impacting First Tee at Pebble Beach Golf Links on September 15-20, 2026.

**Eligibility Requirements:**

- Each Chapter may nominate up to **five** participants
- Participants must be between 14 and 18 years old (applicants must reach 14th birthday by the first day of the event date and not have reached their 19th birthday by the event’s conclusion)
- Classified as a high school freshman, sophomore, junior, or senior as of spring semester 2026
- Since this event has male and female divisions, all participants must select one of these divisions during the application process. For any questions or concerns, please email [support@firsttee.org](mailto:support@firsttee.org)
- Entered in Salesforce and has been an active participant for a minimum of two years
- Exceptional Playing Ability – Applicants are selected based solely on their golf ability and should be able to shoot below 85 for 18 holes
- Participants who have previously attended this opportunity are eligible to reapply
- If selected, the participant must be able to travel with a parent/guardian to Chapel Hill, NC on June 21-26, 2026

Applicants will be selected based solely on their golf ability and evaluated based on their Golf Resume, Junior Golf Ranking, and GHIN handicap using the prioritized criteria below:

Selected participants will be notified on April 29, 2026.

**Travel & Stipend Information:**

Selected participants will be required to travel with a chaperone and will be provided lodging at The Carolina Inn from Sunday, June 21 through Friday, June 26 with the option to depart following the conclusion of play on Thursday, June 25. Breakfast and lunch are provided during practice and tournament rounds. Dinner will be provided during the Welcome Reception on Monday evening, and during the Tournament BBQ the night before the final round. Transportation is NOT provided, and participants/chaperones will be responsible for making rental car arrangements.

First Tee will provide each participant who will be flying with a stipend of up to \$600 to assist with the cost of airfare ONLY. Participants who live within 150 miles of the University of North Carolina at Chapel Hill will be required to drive and are not eligible to receive a travel stipend. Mileage stipends will not be provided to participants who choose to drive to the event. Stipends will be sent directly to the Chapters following the conclusion of the event.

**Policy on the Use of AI in Event Applications:**

To maintain fairness and uphold the integrity of the application process, the use of artificial intelligence (AI) tools, such as text generators or automated writing assistance, is strictly prohibited when completing event applications. Applicants are expected to submit original responses that reflect their own thoughts, experiences, and perspectives. Submissions found to include AI-generated content may be disqualified. We value authenticity and encourage all applicants to share their unique voice and genuine enthusiasm in their applications.

**Participant Submission Policy:**

Online application **must be submitted by the First Tee participant. Applications submitted by a parent, guardian or Chapter representative will be automatically disqualified.** First Tee will not accept paper applications, emails, or correspondence from families of participants. The deadline to apply online is March 18, 2026.

Suggested attire for activities will be sent to participants prior to each event. Proper attire is required at all times including meetings and free time. Questionable attire will be reviewed by on-site staff. Should a host facility have a stricter dress code, its policy will take precedence.

## Social Media Code of Conduct

First Tee will use the reasonable standards of care within its industry for any storage, transmittal, or protection from disclosure of any data, and it will follow standards of care that are the same or greater than the standards of care that First Tee uses to protect other individual data.

**Photo Release**

I attest that I am the parent or guardian of the below named Minor who is participating in and/or attending the Event. I hereby voluntarily release, discharge and agree to hold harmless First Tee and its agents, consultants, employees, independent contractors and other representatives from and against any and all claims, damages, expenses (including without limitation reasonable attorneys' fees) and liability arising out of or relating to the Image(s), including, without limitation, any blurring, distortion, alteration, optical illusion, or use of such Image(s) in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said Image(s) or in any subsequent processing thereof, as well as any publication thereof, including, without limitation, claims for libel or invasion of privacy.

**Facial Recognition Policy**

First Tee has instituted this Facial Recognition Policy ("Policy") to define the policy and procedures for its collection, storage, disclosure, use, protection, and destruction of the data using First Tee's facial recognition technology for photo storage, categorization and to enable First Tee's marketing efforts by making photos easily searchable. Each time the Minor attends an event where photos are taken, photos of the Minor, which includes the resulting biometric data (i.e., the Minor's unique facial characteristics ("Biometric Data")), (collectively, "data") will be recorded and stored within First Tee's photo storage processor's system of record. If you, the Parent or Guardian, consent below, the Minor's data will be stored and used to automatically identify the Minor on subsequent uses for the purposes described in this Policy. This will allow First Tee to ensure individuals are recognized in First Tee's database and enables First Tee to locate and identify photos that First Tee may post on social media and on the internet. It is First Tee's policy to ensure that individual data is used and handled in accordance with all applicable laws.

**1. Scope.**

This policy applies to: (i) First Tee's events and all individuals whose photos may be captured at such First Tee events and activations and (ii) photos provided to First Tee.

## 2. Biometric Data.

First Tee uses facial recognition software purchased from or provided by its third-party vendor, as part of First Tee's photo storage and organization. The software scans an individual's face for purposes of verification in connection with First Tee's storage and organization functions to ensure that individuals are recognized. The devices use a secure technology that generates an encoded mathematical representation. First Tee securely stores these representations in a secure space made available by a third-party provider in a cloud environment for that purpose.

## 3. Additional Information Around Consent.

With respect to consent herein, I agree that First Tee and any third-party subcontractors processing may include activities such as photo organization and storage, equipment servicing, database maintenance, software repair, data restoration, or maintenance backup copies necessary for related activities, even if such activities never occur. Third-party subcontractors can only access such data pursuant to First Tee's instructions and authorization. Individuals may revoke their consent on behalf of the Minor at any time by notifying First Tee [here](#). First Tee will provide reasonable accommodations to those individuals who refuse to consent to the collection and use of their data as described in this Policy. Additionally, by consenting to this Policy, you acknowledge and agree that you are 18 or older and provide consent for the use of images of the Minor named herein in accordance with this facial recognition policy.

## 4. Use, Disclosure, Protection, Storage, and Destruction of Data.

Individual data will only be used for the purposes and related activities set forth in this Policy. First Tee will not sell, lease, trade, or otherwise profit from an individual's data. First Tee will not disclose, re-disclose, provide access to, or otherwise disseminate any data outside of the terms of the Policy, unless:

- The individual or the individual's legally authorized representative provides consent to such disclosure.
- The disclosed data completes a financial transaction requested or authorized by the individual or the individual's legally authorized representative.
- The disclosure is required by state or federal law or municipal ordinance, or
- The disclosure is required pursuant to a valid warrant or subpoena issued by a court of competent jurisdiction.

First Tee will obligate its subcontractors to comply with this Policy.

**Release of Liability and Acknowledgement of Risk**

In consideration of my minor child for whom I am the parent/legal guardian ("Child") being permitted to participate in the First Tee National Championship and associated activities (the "Event"), I, the undersigned parent/legal guardian, in full recognition and appreciation of the dangers and hazards inherent in participating in the Event, do hereby agree to assume all risks and responsibilities, whether known or unknown, surrounding and pertaining to my Child's participation in the Event.

Further, I do for myself, my Child, and my personal representative(s), heirs and assigns, hereby agree to defend, hold harmless, indemnify, release and forever discharge PGA TOUR First Tee Foundation, Inc. ("TOUR"), the title sponsor of the Event (if any), the Event facility (the "Facility"), the host organization (if applicable), and their affiliates and subsidiaries as well as each of their respective officers, directors, agents, members, officials, employees (collectively, "Indemnified Parties") from and against any and all claims, demands and actions, or causes of action, on account of damage to personal property or personal injury (including death) which may result from my Child's participation in the Event (including without limitation transportation to or from the Event), whether or not such injury or damage or death was caused by the Indemnified Parties' acts of negligence and whether or not such injury or damage or death occurred at the Event location. I accept full responsibility for the costs of treatment for any injury or damages suffered by myself or my Child relating to my Child's participation in the Event.

Additionally, I do, for myself and my Child acknowledge that COVID-19 is extremely contagious and that despite the measures the Event has implemented to help mitigate the risk of transmission, the elimination of risk of exposure and infection to COVID-19 is not currently possible. Accordingly, I do, for myself and my Child, assume all risk and danger arising out of attendance at and/or participation in the Event, including out of or related to COVID-19.

Also, I give permission for my Child to participate in all activities sponsored by or associated with the Event and to travel in the vehicles provided by Event personnel. I understand that all and any transportation provided in connection with the Event will be provided by adults with a valid driver's license. I further understand that such transportation may be provided by one or more independent, third-party contractor(s) and not by First Tee. I hereby release the Indemnified Parties from all liability for my Child during travel to and from Event activities.
